2024 plumbing permit fee schedule
<p>(Fees shown are only valid for the year 2024; please call for fees in different years.)</p> <p>Plumbing permits for installation, replacement or repair within a single-family home shall be \$75 plus 1.75% of the job valuation.</p> <p><i>(State surcharge is .0005 times the job valuation. Call the St. Louis Park Building and Energy Department at 952.924.2588 for state surcharges on all permits valued at \$1 million or more.)</i></p> <p>When applicable, a plan review charge equal to 35 percent of the plumbing permit fee will be added.</p> <p><b>Exceptions:</b></p> <p>Installation, replacement or repair of a single plumbing appliance within a single-family dwelling shall be \$75 + \$1* = \$76.</p> <p><i>*State surcharges are calculated at \$1 for single item permits issued under this exceptions.</i></p>
