Dear Community Member:

A number of streets in your neighborhood have been scheduled for rehabilitation during the 2025 construction season as part of the city's Pavement Management project. The project includes work in the Cedar Manor, Westwood Hills and Kilmer Pond neighborhoods. There are different construction activities going on throughout the neighborhoods. **Please see the attachments for a project map and an overview of project scope.**

Project scope overview

- Street rehabilitation and curb replacement
 - The streets included in the project will have pavement replacement and segments of concrete curb replaced to fix drainage issues.
- New sidewalks
 - As a part of this project, new sidewalks are proposed. Sidewalks allow pedestrians, including those in a wheelchair or visually impaired, to safely move around the city by means other than a vehicle. Sidewalks enhance connectivity and promote walking.
 - The city's sidewalk planning framework has a goal of having continuous sidewalks on at least one side of the street on low-volume residential roads.
 - Inclusion at this stage in the process does not predetermine final recommendations. Staff recommendations will ultimately be based on context-sensitive design solutions. This will include factors like traffic volumes, tree impacts, private property impacts, available right of way and cost.
 - It is possible that not all sidewalks evaluated on a project will be recommended or approved for construction.
 - The decision on whether to construct proposed sidewalk segments will be made by the city council as a part of the project approval process in January-February 2025.
 - The sidewalk segments proposed as part of this project will be designated as neighborhood sidewalks, and snow removal will be the responsibility of the property owner.
- Public utilities
 - The city will repair existing storm and sanitary structures and pipes.
- Private utilities
 - This project is also an opportunity for private utility companies to replace or add new facilities in the neighborhood. The private utility work is not part of the Pavement Management project, but the utility companies will schedule their work to be completed in the fall of 2024 or spring of 2025 before construction begins.

The 2025 Pavement Management project is included in the Capital Improvement Program approved by the St. Louis Park City Council. These improvements are proposed to be paid for using city funds; there are no proposed assessments to property owners for this project.
